Section One - Rules/Regulations

I hereby agree that I meet all the requirements and rules:

- I certify that I was born a biological female, is and has always been a female, and that I am medically and legally a female,
- I am a citizen of the United States or country of the title I am competing as,
- I am in reasonably good health and moral character,
- I am able to meet the commitment and job responsibilities as set forth by the Ms. Senior World Pageant,
- I will conduct myself at all times with the dignity, grace and good manners of a woman who exemplifies the integrity of the Ms. Senior World Pageant,
- I will cover all tattoos during competition and appearances,
- I will never smoke or be intoxicated while wearing my crown and banner,
- I will make one documented not-for-profit appearance per calendar month,
- I will observe the rules and regulations beginning with the official check-in at the Host Hotel acting as headquarters for the Ms. Senior World Pageant events through my departure from the hotel following the Finals/Crowning of the Pageant,
- I will not participate in an interview, photo session, or engage in any press contacts or publicity OF ANY KIND during the Pageant events unless a member of the Pageant staff is present and I receive prior approval from Ms. Senior World staff.
- I will not attend any function or make any public appearances other than at regularly scheduled events during the competition week. "Free time" is defined as time on my own. I understand that I may not participate in an interview, photo session, have press contact or publicity of any kind (free time or

otherwise) unless a member of the Pageant staff is present and I receive prior permission of the Ms. Senior World staff.

- I, together with my family, friends, and/or representatives will not be in the company of, or approach, a Pageant Judge before, during or after the Competition. It is not appropriate or acceptable for a Delegate, family or friends to question the Judges for their opinions or comments.
- I will not invite anyone backstage or on stage following the Pageant, at any time except as announced by the Executive Director or Pageant Staff,
- I will advise family, friends and/or representatives that they are not to come on stage at the conclusion of the Pageant until the Pageant staff has announced their approval. The Pageant photographer and videographer need to take many official pictures of the winners and the court, and each Delegate's cooperation is asked and expected. Any problem, concern or complaint will immediately be referred to Pageant staff,
- I will maintain a punctual time schedule in order for all phases of competition, including rehearsals, to run smoothly. I will cooperate fully with the Pageant staff and be on time for all events as outlined in the time schedule,
- I will be officially released from my contract with the Pageant Event at midnight on December 31 of the year I hold State title. Following, I will be the 2021 National Queen. The new 2020 titleholder must remain with Pageant staff after the crowning and photoshoots are completed. The Winner and Runners-Up Agreements take effect immediately upon crowning.
- Should I win the Ms. Senior World title for my division, I will attend at least twelve not-for-profit appearances during my reign, inform the Executive Director of such appearances and forward photos of the event, including location, names in photo titles(s) and position.
- I will not compete in any local, preliminary, state or national pageant as long as I hold a Ms. Senior World state title.

Section Two - Code of Conduct

- I shall not engage in conduct that will bring adverse criticism to the organization,
- I will proudly represent my State / Country and participate in all required Ms. Senior World Pageant events,
- I will be respectful of everyone's time and be punctual to all Pageant scheduled events,
- I will conduct myself at all time with dignity, grace and good manners whenever I am wearing my crown and/or banner, representing my State / Country or the Ms. Senior World Pageant,
- I understand that any misconduct, negative innuendos or misrepresentation of myself or other participants, through any form, be it oral, written and/or by my actions, will be grounds for my disqualification, without question,
- I will not participate in any interview, photo session, press contact, or publicity of any kind during the Ms. Senior World Pageant events unless a member of the Pageant staff is present or I have prior approval of the Ms. Senior World staff.
- I will not be in the company of, or approach, a Ms. Senior World Pageant Judge before, during or after the competition. I will instruct my family, friends and/or representatives to also abide by these requests. I understand that my scores and judges' comments, if any, will be sent to me four (4) weeks after the Ms. Senior World Pageant.
- I understand that no parent, friend, family member and/or representative is allowed backstage except as advised by the Executive Director or Pageant Staff,
- I will advise my parents, family, friends and/or representatives that no one is allowed on stage immediately after the crowning to allow time for the Pageant Photographer and Videographer to take the official pictures of the winners and their courts.

Section Three - Audio / Photo / Video / Advertising

- I will grant the Ms. Senior World Pageant the right to use my name, image, and/or performance for their use in any manner as deemed necessary in the promotion of the Ms. Senior World Pageant(s), without limitation, and without payment,
- I hereby waive any right to approve the finished photograph(s) or any copy that might be used in conjunction with the finished photograph/product,
- I understand that the Ms. Senior World Pageant, the trademark holder, the Executive Director, their staff, successors or assigns, are not responsible for the quality of the photography and/or videography of the Ms. Senior World Pageant and its events and that any issues regarding these products must be taken up with the vendor(s) directly.
- I hereby forever release and discharge the Ms. Senior World Pageant, the trademark holder, the Executive Director, their staff, successors or assigns, from any claims, actions, and/or damages whatsoever by reason of any such use,
- I will provide and submit all advertising materials for the Ms. Senior World Program Book by the deadline set forth by the Executive Director. I also understand that failure to meet the deadline, for whatever reason, will result in my advertisement(s) or sponsor listing(s) being omitted from the Official Ms. Senior World Program Book.
- I hereby release the Ms. Senior World Pageant, staff, successors and assigns, from any liability from any omission; typographic error, reproduction quality, and/or printing error that may occur in the relation to my ad or sponsor listing that will appear in the official Ms. Senior World Program Book.
- I will submit a clear Headshot for the Contestant/Delegate page in the Ms. Senior World Pageant Memory book by September 1, 2020. No exceptions!!!
- I will submit a clear Photo, Title, Sponsor(s) by the September 1, 2020 due date to be used on my free one page Ad for the Ms. Senior World Memory Book. No logos, sponsor name only!

Section Four – Hold Harmless & Indemnity

- I understand and agree that in order to participate in the Ms. Senior World Pageant events and the Pageant itself, all outstanding fees must be current and paid in full. Failure to submit final payments by September 1, 2020, (deadline date) will result in my disqualification from competing in the Ms. Senior World Pageant, without question,
- I understand no title, crown or sash will be awarded until the entry fee is paid in full,
- I do hereby waive, release and forever discharge Ms. Senior World Pageant, the trademark holder, the Executive Director, their employees, representatives, executors, successors, and assigns from any and all responsibilities, or liability or injury, or damages, or accidents resulting from my participation in any Pageant activities. I do also hereby release all those mentioned, and any others acting on their behalf, from any responsibility or liability for any accident or injury or damage to myself, including those caused by the negligent act or omission of any of those mentioned or others acting on their behalf or in any way arising out of or connected with my participation in any activity related to the Ms. Senior World Pageant,
- I understand that if for any reason I am unable to attend the Ms. Senior World Pageant (or I am disqualified from the Ms. Senior World Pageant) that no portion of my fees and/or required expenses will be returned. And, agree I am fully aware THERE WILL BE NO REFUNDS for any reason.

- I will take full responsibility for and agree to release the Ms. Senior World Pageant, the trademark holder, the Executive Director, their staff, successors or assigns, from liability for any losses, damages, claims, or debts incurred or made by me, my family, friends, and/or representatives in connection with the Ms. Senior World Pageant and its events,
- I agree to take full responsibility for any losses, damages, claims or debts incurred or made by myself or any member(s) of my party, in connection with my participation in the Ms. Senior World Pageant. These include, but are not limited to, travel, transportation, pageant ensembles, meals, and any additional out-of-pocket expenses I incur, and any and all personal property brought to the pageant and/or pageant-related events. Failure to settle all debts at checkout will be handled between hotel and contestant. I must contact hotel for reservations and check-in requirements.
- I understand that the decision of the Judges is final, without question.
- I agree to participate in all Ms. Senior World Pageant events (see Handbook). Disagreements, of any kind, between me, my family, friends and/or representatives and the Ms. Senior World Pageant will be handled in independent arbitration, for which expense I will be responsible and whose decision will be final.

Section Five – Winner and Runners-Up Agreement

- Should I win my division, Ms. Senior World title, I will not, during my reign, compete in any other Pageant competition, be it local, preliminary, State, National, or International,
- Should I win the Ms. Senior World Title, I agree to embrace and proudly promote the title, crown, and banner of my Title, and will do so until the title is passed on to my successor,
- Should I win the Ms. Senior World title, I agree to promote Ms. Senior World Pageants to my fullest abilities.
- Should I win the Ms. Senior World Title, I will receive approval from the Executive Director prior to scheduling at least twelve not-for-profit appearances during my reign.
- I forever release the Ms. Senior World pageant, the trademark holder, the Executive Director, their successors, staff, and assigns from any damage or injury incurred in travel to, from, and/or during the Ms. Senior World Pageant and its events,
- Should I win the 2020 Ms. Senior World Title for my division, I agree to sign the Winner's Contract with more specific details including, but not limited to, my return to the Ms. Senior World Pageants in 2021 to crown my successor, appearances, expenses, and other items that may not have been outlined herein,
- I will take full responsibility for and agree to release the Ms. Senior World pageant, trademark owner, the Executive Director, and their staff, successors and assigns from liability for any losses, damages, claims, or debts incurred or made by me, my family, friends, and/or representatives in connection with the Ms. Senior World Pageant and its events,
- Should I win the Ms. Senior World Title for my Division, and cannot meet the required obligations, I will forfeit my Ms. Senior World Title, my Ms. Senior World crown and sash, and all my prizes to the 1st Runner-Up, as selected by the Ms. Senior World Judges,
- If I place as a Runner-Up, and the Ms. Senior World Title for my division defaults to me, I understand and agree that I must meet all eligibility requirements at the time of the default, and be bound by the provisions of this agreement. If I do not meet all eligibility requirements at the time of the default, the title will be offered to the next delegate as indicated by the official pageant scores.
